

## Humanities and GLAM sector not represented on ARC Advisory Committee

DASSH notes with serious concern the complete lack of representation of the humanities or GLAM sector within the advisory committee established by the Australia Research Council.

We acknowledge the inclusion of both Distinguished Professor Maggie Walter and Professor Deborah Terry AO, Vice Chancellor and President, University of Queensland both of whom have backgrounds in the social sciences.

The decision to exclude the humanities and GLAM sector from this distinguished list further entrenches the lack of representation for these sectors at the ARC.

With the implementation of the Commercialisation of Research Action Plan, the research environment is already undergoing a significant shift towards industry affiliated research, putting our disciplines at a disadvantage.

The Humanities and Arts industries, particularly, history, heritage, galleries, libraries, archives and museums provide a rich array of industry experience on which ARC can draw and from which it can benefit.

The neglect of these is damaging both the intent of the Ministerial direction to gain more insight into the end users of research as well as to those researching in these fields

DASSH argues that the inclusion of representatives from our disciplines will fundamentally boost the effectiveness of the consultation process through well rounded advice from highly recognised professionals in their fields.

Without this advice this consultation process will result in skewed findings that do not represent the whole of the Australian research sector nor even Australian society.

DASSH is calling on the ARC to appoint at least two members of Australia's distinguished humanities and GLAM sectors to this committee.

“Dr Ayres has worked in research libraries for more than 25 years, after completing a PhD in Australian Literature at the Australian National University. “Dr John Vallance attended the University of Sydney where he studied classics and archaeology, followed by Cambridge where he completed his MA and PhD in classics at St John’s College. He has published widely in the field of ancient Greek science and medicine. Between 1999 and 2017 he was Headmaster of Sydney Grammar School. He has served as a member of the Library Council of NSW and as a Trustee of the State Library Foundation, and is currently a non-executive director of the Sydney Symphony Orchestra. He is also Honorary Professor for the Public Understanding of the Humanities at the University of New South Wales.”
